### Divisional Commanders Message

October marked the first ever Leith 'week of action', a joint partnership initiative which proved incredibly successful. Lothian and Borders Police linked in with the City Council, the Fire and Rescue Service, Neighbourhood Watch groups and local residents. As well as tackling crime at a local level head-on, our officers were able to build links with the local community and develop an ongoing mutually beneficial relationship. The scheme has the potential to be rolled out in other areas as time goes on.

### Door Step Crime

At any time of year they could arrive on your doorstep, cold callers or bogus callers, call them what you may.

They take on many faces pretending to be from a utility company, charity collector, the 'plumber' working next door, selling over priced goods, using hard selling techniques or overcharging for work, they all want one thing; your money, and will try many ways to get it.

It is important to take some simple precautions so that such people do not take advantage of yourself or others.

- **What do these people look like?** They are plausible people, dressing and talking in such a way to inspire confidence in you to 'trust' them. Do not get taken in.
- **Who is at risk and when?** Many bogus callers will call during the day – times that you would expect trades people and service providers to call. Charity collectors will call at various times.
- **Bogus Callers are always inventing new ways of getting into people's homes to steal valuables or money.** If you do not know or expect a caller, do not let them into your home.
- **What can you do?** Always check who is at your door before you open it. If you have a door chain use it.
- **An expected a caller.** Check they are genuine, they will show you ID and you can contact the company; using the phone book to get the company telephone number to confirm the callers identity.
- **Doorstep workman.** Don't let any casual caller do work on your property, for example roofing, driveway or gardening work.
- **Be aware.** Be careful yourself and lookout for neighbours, if suspicious people are in the area, contact the police.

# Local News

Welcome to the latest edition of the Community Newsletter for 52 Beat in the City Of Edinburgh.

In recent weeks there a number of garden huts have needlessly and maliciously been set on fire in and around the Stenhouse Crescent area of the beat. A number of huts have also been broken into and an assortment of tools stolen, many of which have been found discarded at the locations of other crimes. Although enquiries are ongoing into a number of these incidents, I can report that two teenagers who were recently arrested in the locality have confessed to a large numbers of such crimes. A report is currently being prepared for the attention of the Children's Reporter in connection with this.

I have attached a relevant crime prevention leaflet relating to garden crime, which I hope you might find of some use. Additional information can be obtained from our Crime Prevention Officer, PC Bert Wilson, whose number is highlighted below.

Whilst making local enquiry into the matters highlighted above and having spoken to other residents across the beat area it is still evident that a number of issues that affect the community are not, for a variety of reasons, being reported to the police. I cannot emphasise enough the importance of keeping us abreast of ongoing events in order that some consideration can be given an appropriate level of response.

Following several crimes in and around the pedestrian underpasses in Calder Road arrangements have again been made to site temporary CCTV cameras at appropriate locations in the area. These will hopefully assist with the identification of individuals who may be involved in crimes there. You may be interested to know that The Sighthill, Broomhouse and Parkhead Community Council have arranged a public meeting to discuss issues surrounding these underpasses. Senior police officers from Wester Hailes Police Station will be attending the meeting, which is to be held at 7pm on Wednesday 19 November 2008 in Murrayburn Primary School.

The City Of Edinburgh Council has now made a formal planning application to build a new state of the art skate park in Saughton Public Park. This proposal has given rise to much public debate and will no doubts continue to do so. Primarily, as a result of the discussion that has arisen with regard to ongoing problems associated with the park and it's future a group of local residents have decided to investigate the possibility of starting a 'Friends Of The Park Association'. Such groups already exist at a number of other city parks. If anybody would like any further information regarding this proposal please get in touch and I'll pass details onto those involved.

Guy Fawkes night, (November 5<sup>th</sup>), this year passed off with relatively few problems, Lothian and Borders Fire and Rescue Service apparently reporting one of their quietest in years. As usual there were a number of 'unofficial' bonfires throughout the area but these were relatively small affairs and posed no danger to adjacent buildings etc. An organised bonfire and firework display was held at Sighthill Park and took place under the guidance and supervision of The Community Safety Concierge Service and local police officers.

A letter has recently been by the police from DEYA Limited with notification that their distribution of the Yellow Pages will commence in many of our local postcode areas on 27 November and will last for some 2 or 3 weeks. Delivery agents will be instructed not to leave copies of the book on view from the street, as any left for protracted periods of time may indicate that residents are perhaps on absent or on holiday. It is probably unavoidable, however, that this will occur from time to time. You might want to consider doing the 'neighbourly thing' by uplifting copies delivered to those you know to be away from home.
